The following charges shall take effect from 1<sup>st</sup> January 2025.

within 12 hours of advised Perth Pilot boarding time	50% of charge + expenses
<b>Detention on board</b> <i>(per hour or part thereof)</i>	£75.00 per hour + expenses
<b>Berth Shift within the Port</b>	75% of length charge + expenses
