- The Contractor will be responsible for ensuring the Dive Operation is conducted in full compliance with "Diving at Work Regulations 1997" and "Commercial Diving Projects Inland/Inshore Approved Code of Practice", and subsequent amendments.
- The Contractor is to prepare and present for review a Dive Plan, site and task specific risk assessments, and Safety Plan which also identifies the arrangements in place for the treatment of any cases of suspected decompression illness
- 3. Dive operations shall not interfere with other vessel movements unless previously approved
- 4. All near misses or accidents must be reported to Harbour Operator/Harbour Office.
- **5.** Site facilities and all reasonable support will be provided to the Supervisor or Diving Contractor in the event of an emergency.
- 6. In signing this permit the Master/Skipper of any vessel under which the dive operations will be undertaken, and the Dive Supervisor, declare that all necessary precautions have been taken to reduce to ALARP, the hazards to divers from propulsion systems, inlets, outlets, etc. and will remain in place until the Dive Supervisor confirms all divers are clear of the water.
- 7. Where diving is taking place on/on behalf of a vessel, or proximity to a vessel, the Master(S) shall provide assurance of vessel isolation*
- The Dive Supervisor shall comply with all instructions issued by the Harbour Master. If using a dive tender; at all times shall display flag 'A' and at night additional lighting to highlight the operation.

I declare that the aforementioned requirements have been satisfied. Precautions have been taken and will be maintained for the duration of the dive operation, and will not operate outside of the stated area and times.
