For vessels taking bunkers alongside within Perth Harbours jurisdiction, from a fuel barge, bunker vessel or road tanker, this form must be submitted by 12:00 on the preceding working day, Mon-Fri, and by 12:00 on Fridays for weekend bunkering operations up to 12:00 on the Monday, or Tuesday if there is a Bank Holiday Monday.

All transfers to be conducted in accordance with Perth Harbours Standing Notice to Mariners SN02.
